Maximum Federal Sentence for Most Egregious Conduct/Defendants: 2 years

All but 2 of the 30 convicted State Defendants faced sentences of <u>more</u> than 2 years, the maximum Federal sentence. The 2 who faced less, Washington and Smith, had charges reduced due to a failure of supporting evidence. The federal sentences, in essence, set a ceiling for punishment though we continued to push for convictions that carried heavier sentences.

General Facts:

(From "Strengthening Charleston: Assessment of the Charleston Police Department Response to the May 30-31, 2020 Protests / Riots: Final Report")

During the riots and protests of May 30 and May 31, rioters attacked and destroyed businesses and vehicles within the City. Members of the Charleston Police Department, the Charleston Fire Department, civilians and members of assisting agencies were also injured. Despite these injuries, there were no deaths or serious injuries. However, many buildings within the City of Charleston sustained significant property damage. The damages and injuries sustained caused significant costs to businesses and property owners throughout the City.

8:20 p.m. – On surveillance footage, the defendant committed a municipal level assault and then jumped on the hood of a car saying - "Here we go. Tear that boy's shit up! We going to fuck shit up down here!" [Inciting a Riot charge.]

8:52 p.m. – The defendant poured an accelerant into a parked police vehicle, but it won't light. "I need something to light this shit!" he said. The defendant was then handed a white shirt that another person poured gasoline on. He attempted to light this shirt, but it still wouldn't light. Eventually, he placed the shirt on the ground, where another individual was able to light it and throw it into the car. [Arson, 3rd Degree]

10:02 p.m. – The defendant threw a rock through window of "The Rarebit" restaurant. [Malicious Injury to Property]

10:005 p.m. – The defendant stood behind another person who kicked in the door to "The College Mart." The defendant ran in with the other person and left with merchandise. [Burglary, 2nd Degree]

10:21 p.m. – Surveillance video showed the defendant (acting with another) use a large piece of metal to shatter a window at Charleston Place. The defendant attempted to reach in and remove merchandise but was stopped by security guards. [Burglary, 2nd Degree]

Federal Charges: The defendant pleaded guilty to lighting the police car on fire before Federal District Judge Gergel on July 17, 2021. He received a sentence of twenty-four months active time followed by thirty-

six months of supervised release.

State Charges Resolved: Kelsey D. Jackson pleaded guilty straight up to the state charges that were <u>not</u> factually covered by his federal guilty plea (such as the riot and arson charge). He was facing four charges, each carrying a potential maximum of ten years in prison. He received a 2-year sentence from the Court to run concurrently to his federal sentence.

Convicted of two counts Burglary, 2nd Degree (Non-violent) and two counts Malicious Injury to Property (\$2,000 - \$10,000) on top of federal offenses, for conduct related to the May 30 riots.

Tearra Na-Asia Guthrie 24 years, Atty: James Falk

State Charges / Exposure:

Arson, 3^{rd} Deg. (0-15 years), 2021-3167 (Federally Adopted)

Conduct:

On May 30, 2020, at 8:52 p.m., in the area of Hasell & Meeting Street, Kelsey Jackson (above) and others attempted to light an unoccupied patrol car on fire. They struggled to get the accelerant lit. Jackson was handed a tee shirt by another, which he coated in gasoline. He asked for assistance lighting the tee shirt. This defendant lit the shirt with a lighter, after which it was thrown into car, burning the vehicle.

Federal Charges: The defendant pleaded guilty to the federal charge of Civil Disorder on May 30, 2020. She was sentenced to time-served with one-year supervised release.

RESOLVED: The Defendant passed away prior to the resolution of her State charge.

Conduct:

5/30/20 (Burglary 2nd Degree [V] x2)

During the riots of May 30, 2020, the defendant entered 468 King Street, The "El Jefe" Restaurant. The defendant entered the building through a previously broken window. The restaurant had been cleared out by previous trespassers, but the defendant later admitted to going in the building in order to steal alcohol, but all had already been taken.

That same night at 543 King St. (The College Market), while streaming live on Facebook, the defendant entered the market and took a 6-pack of Angry Orchard Cider. Throughout the video, the defendant encouraged damage and for others to join, for example: "if y'all ain't with the gang, you're gonna get ganged."

Federal Charges: FEDERAL CHARGES: The defendant pleaded guilty on August 26, 2021, in federal court to a violation of the federal Anti-Riot Act as well as charges related to a previous gun charge. Federal District Judge Gergel sentenced the defendant to two-years active time followed by three-years supervised release.

RESOLVED: Defendant pled straight up to two counts of Second-Degree Burglary (NV), each carrying a potential ten-year sentence. He received a sentence of two years to run concurrently with his federal sentence, on July 12, 2022, before the Honorable Judge Bentley Price.

Convicted of two counts Burglary, 2^{nd} Degree (Non-violent) on top of federal offenses, for conduct related to the May 30 riots.

Conduct:

5:01 PM – The defendant jumped up and down on Mount Pleasant Police Cruiser, while inciting others to do so but they refused. He repeatedly jumps on cruiser causing \$2,500 - \$5K in damage. [Mal. Inj. to Prop., \$2K - \$10K] One of the earliest people to begin encouraging others to commit property damage.

Later, the defendant blocked traffic and sprayed a fire extinguisher at law enforcement. (Municipal Charge – A&B, 3d Deg.).

The defendant then used the same fire extinguisher to break out windows in unoccupied Charleston County and CPD vehicles. (Municipal Charge – Mal. Inj. to Prop.)

At 8:52 p.m., the defendant threw a flaming t-shirt into a parked, unoccupied CPD vehicle near Meeting and Hasell Streets. Later upon questioning, the defendant admitted to squirting lighter fluid into the car as well. This act resulted in the vehicle being destroyed by flames. [Arson, 3rd Deg.]

At 9:12 p.m., surveillance footage shows a CPD officer who was attempting to make an arrest, swarmed and pushed over by a group of rioters. The defendant was identified as one of the people running toward the officer and part of the group that pushed him over.

Later that night, the defendant was also seen on camera throwing water bottles at officers. (Mag. Charge - A&B, 3rd Deg.)

Citing much of the above conduct, Δ is also charged with inciting or participating in a riot.

Victim officer contacted regarding guilty plea and agreed with straight up guilty plea.

Federal Charges: The defendant pleaded guilty to Civil Disorder in federal court before the Honorable Judge Gergel on July 8th, 2021. He received an 18-month active sentence followed by 3-years of federal supervised release.

RESOLVED: Defendant pleaded guilty before the Honorable Judge Bently Price on January 12, 2022, to all State charges except the Participating in a Riot charge (conduct covered by his federal plea). He pled to Assault and Battery, 2nd Degree, which carried a potential 3-year sentence, Arson, 3rd Degree, with a potential

15-year sentence, and Malicious Injury to Property, a potential 5-year sentence, in a straight up plea. He received a sentence of 18 months to run concurrently to his federally imposed sentence.

Convicted of Assault and Battery, 2^{nd} Degree, Malicious Injury to Property, and Arson, 3^{rd} Degree, on top of federal offenses, for conduct related to the May 30 riots.

Conduct:

<u>5/31/20</u> – 4:48 a.m. (post riots) – The defendant Harold Blake and Co-defendant Dilligard entered Vintage Lounge at 545 King Street (a previously looted business) through broken windows and took seven bottles of liquor. They were caught nearby with the merchandise when citizen onlookers flagged down law enforcement.

Other Pending Charges: Multiple for Blake. Harold Blake continued to be rearrested for other property offenses during the pendency of his charge arising on May 30, 2021.

RESOLVED (Anthony Dilligard): Defendant Dilligard pleaded guilty straight up to Burglary, 2nd Degree [nonviolent]. He was facing a potential ten-year sentence with this guilty plea. His attorney had secured him a bed at an inpatient drug treatment center where he would go after the plea. The Honorable Judge Bently Price sentenced him to the 446 days he already served, allowing him to pursue treatment.

RESOLVED (Harold Blake): Defendant Harold Blake pleaded guilty straight up to Burglary, 2nd Degree [non-violent] before the Honorable Judge Bentley Price on December 12, 2022. He also pleaded guilty at this time to other offenses unrelated to the May 30, 2021, riots. He was facing a potential sentence of over thirty-five years. He was sentenced to 273 days he had already served for these offenses.

Each convicted of Burglary, 2nd Degree (Non-violent) for conduct related to the May 30 riots.

RESOLVED: Defendant pleaded guilty straight up to this offense on August 14, 2023, before the Honorable Judge Jennifer McCoy. He was also pleading straight up to a charge unrelated to the May 30, 2021, riots (Pointing & Presenting a Firearm). He received a Youthful Offender Act sentence suspended to one-year probation.

Convicted of Malicious Injury to Property for conduct related to the May 30 riots.

Dasean Shoki Hughes

Conduct:

At around 8:25 PM on May 30, 2020, the defendant smashed out a window of a Charleston Police Department marked cruiser. Then, as a codefendant (Jackson, see above) poured lighter fluid on the vehicle, defendant Hughes assisted in lighting the vehicle by providing his shirt as a starter for the flames. He did not actually light the vehicle or the shirt on fire.

RESOLVED: The defendant pleaded guilty straight up to Arson, 3rd Degree on May 15, 2024, before the Honorable Judge Jennifer McCoy and received a 1-year sentence suspended to 1-year of probation.

Convicted of Arson, 3rd Degree, for conduct related to the May 30 riots.

Quincy Ross Summersett

Conduct:

On May 30, 2021, the defendant entered a previously smashed door at the "Uncork" wine bar and took a bottle of wine. He also entered the previously smashed door of "Metro PCS" (a phone store), grabbed phone boxes and fled.

RESOLVED: The Defendant pleaded guilty straight up to both counts of Burglary, 2nd Degree [Non-violent] as well as a subsequent offense unrelated to the civil unrest (Domestic Violence, First Degree). The plea was heard by the Honorable Judge Deadra Jefferson on October 19, 2021. The defendant received concurrent 3-year sentences on each charge suspended to 3 years of probation, including requirements of drug testing, acquiring a G.E.D., and batterer's treatment.

Convicted of two counts of Burglary, 2nd Degree (non-violent) for conduct related to the May 30 riots.

At 11:30 PM, the defendant entered the Las Olas Retail Store at 441 King St. through a previously broken window and took items from a shelf.

At 11:58 PM, the defendant lingered in front of "Two Cumberland" (a retail store) before trying to reach through the broken glass to open the door. When this failed, the defendant took items from a display table via the broken window.

Following her arrest, the defendant admitted to entering the King St. Grocery and taking an ice cream bar valued at \$3.

Further, video footage shows defendant reaching through a smashed door of CBD Social twice and taking items within her reach.

RESOLVED:

Defendant pled guilty straight-up to 4 Counts of Burglary, 3rd Deg., facing a range of zero to five years on each charge, before Judge Bentley Price on April 5th, 2023. She received a Youthful Offender Act sentence suspended to time served.

Convicted of four counts of Burglary, 3rd Degree, for conduct arising during May 30 riots.

On May 30, at 8:35 p.m., at the Charleston Place Hotel, Watson was identified on video surveillance throwing a rock into the glass doors of the hotel causing approximately \$3,000 in damage. [Malicious Injury to Prop.]

At 8:50 p.m., at the Christian Michi Store at 220 King Street, video surveillance shows the defendant enter the store, grab a purse and leaves with it. [Burg. 2nd Viol.]

At 9:54 p.m., at "The Macintosh" at 479 King Street, Facebook video shows a group of people, including the defendant, enter the business through a shattered window, extensive damage was caused inside. [Burg. 2nd Viol.]

At 10:15 p.m., at "Orvis" at 535 King Street, the glass door was shattered, and multiple individuals entered. The defendant took several items and walked out of the store with them. [Burg. 2nd Viol.]

At 11:09 p.m., at "Shop SXC" at 525 King Street, the defendant entered the store with several others and ran to the back corner of the store and lit a fire that grew as he fled the store. [Arson, Burg. 2nd Viol.]-Federally Indicted 2/8/22.

At 12 a.m., at 543 King Street ("The College Market"), video surveillance [time approx..] showed the defendant enter with many others right after door is smashed by others, approximately \$80,000 in merchandise looted from this location. [Burg. 2nd Viol.]

At 11:55 p.m., at the Sherwin Williams Paint at 472 Meeting Street, multiple suspects smashed the windows and entered the store. This defendant assisted in the lighting of a fire inside the store, causing over \$235,870



in damage. [Arson, Burg. 2nd Viol.] - Federally Indicted 2/8/22.

At 12:46 AM, surveillance video showed the defendant enter "Uncork" (Wine Bar) at 476 King Street and pile up menus and light them on fire. [Arson, Burg. 2nd Viol.] - Federally Indicted 2/8/22.

At 12:55 a.m., at 478 Meeting Street ("Family Dollar"), the defendant was on video surveillance entering the store with several others. The defendant was seen setting several fires and making sure they grow before leaving. [Arson, Burg. 2nd Viol] - Federally Indicted 2/8/22.

5/31/20, 1:40 a.m., 516 King Street ("Athletes Foot") the defendant entered through broken windows with several others, and was seen on video gathering about \$500 in merchandise and exiting store. [Burg. 2nd Viol.]

5/31/20, 1756 Ashley River Road (the "O and E Food Mart"), the defendant entered store after another threw a rock through the front door of the building. Acting with others, he stole a cash register (\$10,000) containing \$300, and a lottery station valued at \$10,000. [Burg. 2nd Viol.; Grand Larceny]

Federal Charges: On February 8, 2022, the defendant was Federally Indicted for the four counts of arson referenced above. He was sentenced by Federal District Judge Gergel on June 7, 2023, to a five-year active sentence followed by 3 years of supervised release.

RESOLVED: The defendant pleaded guilty straight-up to six counts of Burglary, 2nd Deg. (Viol.) in State Court and a before the Honorable Bentley Price, facing a potential 15 years on each count, and was sentenced to 126 days of State incarceration that he had already served. The Court cited its consideration of the 5-year federal sentence which he was already serving at the time of this guilty plea.

Convicted of 6 counts of Burglary, 2nd Degree (Violent) in relation to conduct during the May 30 riots.

The defendant posted a 2.5-hour Facebook live video of the downtown riots. At about 10:21 p.m., at the entrance to the John King Piano Bar, he asked a looter to retrieve him a liquor bottle from the previously looted restaurant, which the other person did. The defendant never entered the business.

5/30/20, 10:30 p.m., The MacIntosh (Bar / Restaurant) at 479-B King Street

The defendant walked by the smashed door of the MacIntosh restaurant. Another person entered the business and this defendant said to him "hurry up, hurry up!" once the other was inside. This defendant never entered the business, nor took any property from this business.

RESOLVED:

These charges were never indicted due to the failure of the allegations to meet the elements of Burglary as a principal and weak evidence of accomplice liability under current law. The defendant pleaded guilty to Petty Larceny in transfer court regarding his admitted theft of the liquor bottle from the John King Piano Bar.

Convicted of Petty Larceny for conduct arising during the May 30 riots.

The defendant was identified as the person throwing a large rock into the glass doors at the Gucci Store in The Charleston Place Hotel causing approximately \$3,000.00 in damage. [Mal. Inj. To Prop.]

May 30, 2020, 9 p.m., 145 Market Street - "Nice Ice" Business

The defendant, along with others, was identified as from video as a person busting into the wooden double doors shared by this business and neighboring Christian Michi. This defendant was seen removing merchandise from the jewelry store. [Burglary, 2nd Deg. Viol.]

Same facts as above, but as applied to the neighboring "Christian Michi" retail business. [Burglary, 2nd Deg. Viol.]

May 30, 2020, 9:37 p.m., 435 King Street ("King Street Grocery")

The defendant was one of many who rushed into this store upon the initial break in. He approached the counter and motioned behind the counter but was rushed out of the store in a mob of people who suddenly leave. He did appear in the video to take any identifiable items. [Burg. 2nd Deg. Viol.]

RESOLVED:

Defendant pleaded guilty straight up to 3 counts of Burglary, 2nd Deg., non-violent, each carrying a potential active sentence of 10 years, 2 counts of Malicious Injury to Property, each carrying a potential 5 years, and Grand Larceny, carrying a potential 5-year sentence. The Honorable Judge Bentley Price sentenced the defendant to 10 years suspended to 5 years' probation, to terminate in 2.5 years if no violations.

Convicted of three counts of Burglary, 2^{nd} Degree and two counts of Malicious Injury to Property for conduct during the May 30^{th} riots.




